He admired and enjoyed nature, particularly the night skies, the changing seasons, animal life, the majestic canyons of the Southwest, and the house plants to which he tended. Classical music filled the background of home and the car and he could astonishingly identify works of music and their composers in seconds. Wordworking was both a hobby and talent, and his gifted ability, hard work, and craftsmanship filled the family home with beautiful cabinets, shelves, tables, and other pieces. He enjoyed classic films and was an avid reader with a personal library filled with volumes of books on many topics.
